- Delivery of Tender.** The tender/quotation will be enclosed in sealed cover which will be invariably marked with quotation against tender inquiry no. **2871/1541/IT-13/Def/Proc/HRF (M) dated 28 Mar 2019** and complete address. The tender if brought by hand, will be handed over to security staff on duty at Gate HRF (M) Heavy Rebuild Factory (M-Series) for placing the same in quotation box (available at gate). The quotation will not be brought by hand by any firm while visiting the offices of Assistant Director (Procurement).
- If required endorsements are not made on the envelope, quotation is liable to be disqualified. The quotation will be opened on **28 Mar 2019 at 1100** hours in the presence of the available representative of the firms in HRF (M), Heavy Industries Taxila. No quotation will be entertained / considered after **1030 hours**, on the aforementioned date.

11. Commercial Offers of technically accepted firms only will be opened later on and date of opening will be intimated to the firms accordingly.
12. The store is required to be delivered at Taxila Cantt within the stipulated period as given in the contract.
13. HRF (M) reserves its right to reject the offer in whole or partially thereof with justification/reason.
14. This inquiry may not be taken as an indication of subsequent purchases and does not in any way commit HIT to purchase the items offered.
15. The store should conform to prescribe specifications as provided by this office.
16. The store will be packed in standard grade worthy of transportation by the means adopted.
17. This inquiry may not be taken as an indication of subsequent supply order and does not in any way commit HIT to purchase the items offered.
18. Payment will be made by the CMA (HIT) Taxila Cantt through cheque against pre-receipted bill (duly affixed with revenue stamp) alongwith professional tax certificate (Photocopy attested) of the supplier after delivery and acceptance of stores.
19. All clauses/terms mentioned in this inquiry will be considered accepted by the firm in case no reference to them is given in the offer.
20. **Offers must remain valid for 180 days** from the date of opening of the tender.
21. ***The prices quoted must be firm and final and inclusive of all taxes, handling charges etc and delivery of any parts req for said store at HIT Taxila Cantt.***
22. Part payment against part item is not allowed.
23. **Postal Order for Rs. 200/-** (Rupees Two Hundred) in favour of MD (M), HIT Taxila Cantt will invariably be enclosed with the quotation, failing which the quotation will be ignored.
24. Firms are instructed not to send Telex and Fax quotations. Such quotations/offers will not be accepted.
25. HRF (M) reserves the right to increase/decrease the quantity or delete the required item.
26. 5% security deposit (of contract value) will be provided by the firm on receipt of the contract. The same will be released after one year from the date of delivery and acceptance of stores.
27. Country of Origin: **All countries except India, Israel and Taiwan.**
28. **Earnest Money All Registered/Un Registered Firms** with HIT can participate in the tender by depositing **2/5% earnest money** of total contract value, respectively. The earnest money will be submitted by the firms in the shape of **CDR/Bank Guarantee** addressing to **Managing Director HRF (M), Heavy Industries Taxila Cantt**. The earnest money will be provided by the firms alongwith their **“Commercial Quotation”**. **Note in this regard be clearly mentioned on technical quotation that 2/5% earnest money is enclosed alongwith commercial quotation. In case clear mentioning of earnest money is not found in “Technical Quotation” offer will be rejected.**
29. “The offered price will be inclusive of 17% GST as imposed by Government of Pakistan. The offers without the inclusion of 17% GST will not be considered.
30. Integrity Pact will be invariably involved / invoked when the total value of the contract exceeds 10 million as specified in PPRA Rule 2002-2004.

31. All registered /un-registered supplier/person who are on Active Taxpayer List (ATL) of FBR are eligible to supply goods/services to Government departments. Supplier will submit certificate to this effect along Technical Quotation.

32. The payment to the registered/un-registered persons is linked with active taxpayer status of the supplier as per FBR data base. If any registered /un-registered supplier is not in active Taxpayer list his payment will be stopped till he files his mandatory returns and appear on ATL of FBR.

33. **Evaluation Criteria.**
